Hello,

Financial update for NRU is as follows:

There is \$2049.90 in the NRU account with Bank of Alpine as of today. Regards transfer of the funding to NRCw&sd: There should be no problem given our Bylaws. Although the District is not a tax exempt organization, it serves the same capacity of NRU.

Please let the record show this comment from CPA Wade Hirschi:

Hi Beth:

Section 9.9 addresses dissolution. It says that the the board shall dispose of the assets "...exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under applicable sections of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) and which is organized for purposes substantially similar to that of the corporation."

Here's my take on that – Basically it says you have to give the money to an organization that qualifies to receive tax exempt contributions under the Internal Revenue Code. Governmental entities by definition qualify for this. Thus, the new district should qualify to receive the money under that provision. The other requirement that it be "organized for purposes substantially similar to that of the corporation" is met because the district would take over the functions that NRU was set up to serve.

So, it appears to me that it would qualify without any hitches.
